2. Describe what happened to you, including dates, places, and the names of people directly involved. Blair County Common Pleas Court - Judge Hiram A. Carpenter altered custody hearing transcripts, denied my daughter-(Stephanie) and I of our Constitutional rights of due process of law and equal protection of the law. There are more details in the enclosures with this complaint form.

3. Were you given any explanation for what happened? If so, what was the explanation given? No explanations were given.

- 4. Why has this happened to you? A court appointed psychologist Nancy Baker was caught on the witness stand for perjury and falsifying the diagnosis of my daughter's psychiatric condition.
- 5. Have you done anything on your own to try and solve the problem? (e.g. filed an appeal, written to a public official) If, so, what happened? (a.) Filed an appeal with the Superior Court. (See number 6 (d.). (b.) Filed a Petition to Correct the Custody Hearing Transcripts along with the hearing audio tapes. Was denied by Judge Hiram A. Carpenter. (c.) At a later date, I filed a Petition to Inspect the Record and provide this petitioner a copy of the hearing audio tapes. Was denied by Judge Carpenter. (d.) Wrote letters to our local Representative Jerry Stern, Congressman B.11 Shuster, Governors Ridge and Schweiker und President Bush. President Bush referred the letter to the U.S. Department of Justice and the others mentioned told me; it was separation of powers and they couldn't get involved.

- 6. Have you contacted another agency? If so, what agency and what is the status of the complaint? (a.) Yes, filed a complaint with the u.s. Department of Justice for a criminal investigation. Their answer was it is a state matter. (b.) Filed a complaint with the Penna. Alterney General-Mike Fisher for a criminal investigation. Their answer was it is the Biair County District Alterney's responsibility to investigate. (c.) Filed a Private Criminal Complaint with the District Alterney-David Gorman. His answer was it is policy that the judge and his court reporters have judicial immunity.

 (d.) Filed an appeal in Superior Court, I hired Alterney Anthony J. Zanon, to file the briefs due on April 23, 2001. He advised me on April 19,2001 to drop the appeal in exchange for an agreement with the Guardian ad litem-Beverly Mears for resumption of joint custody. (e.) Filed a complaint with the Judicial Conduct Board against Judge Carpenter. Their answer was they did the necessary inquiry. (Note: without disclosing the audio tapes of the proceedings). (f.) Filed an Impeachment Petition with the Penna, House of Representatives on February 22, 2002. Their answer is the petition is still under review.
- 7. Have you consulted an attorney? If so, what is the attorney's name and address? CAn we contact this person for more information? Yes, Alterney Anthony J. Zanoni 118 South Juliana Street, Bedford, PA 15522. Yes, but this is the same alterney who destroyed my appeal in Superior Court and his information generally is unreliable.
- 8. What would you like the ACLU to do for you? To investigate and restore my daughter's Constitutional rights that were trampled by this judicial corruption.
