To whom it may concern:

Please find enclosed a letter my sister received from the Department Of Justice dated July 18, 2001. The letter was in response to a complaint my sister filed with this agency regarding Civil Rights Violations and a total disregard for the Constitutional guarantees of Due Process of Law and Equal Protection of the Law. In summary the complaint my sister filed with the Justice Department accused a Common Pleas Court Judge, Hiram Carpenter of tampering with hearing transcripts and fabricating physical evidence that led to the judicial injury of me and my daughter.

Offering no meaningful help, this agency took an indifferent position in the matter concerning judges who commit serious crimes and violate citizen's basic constitutional rights. While this agency refused to get involved in my case by initiating an investigation into the 6 years of endless civil rights violations encompassing my custody case, it did advise that I acquire the services of legal counsel.

Attempting to find some course of redress for the abuse my daughter and I suffered at the hands of our court system, I hired a Blair County attorney by the name of Anthony Zanoni. And yes, in less than three weeks after being involved with my case he became a part of the court corruption to protect and cover up the crimes of the judge that I pleaded with this agency to investigate.

Not to run on about this matter I enclosed an Impeachment Petition against Judge Hiram Carpenter that I filed with the Pennsylvania State Legislature on February 27, 2002. You will also find an amendment to that Petition I filed on May 7, 2002 which outlines the ongoing and expanding judicial corruption that has taken place since your agency chose not to investigate.

After your review of the material I hope that the JUSTICE DEPARTMENT will get involved with this case and recommend that the Federal Bureau Of Investigation look into the corruption of the Blair County Court system of Pennsylvania.
