Mr. Carpenter's involvement with the custody proceedings docket # 96 GN 2139 began on May 22, 1998. Subsequently, Mr. Carpenter held numerous evidentiary custody proceedings in the above captioned matter beginning on August 28, 1998. February 1st, 2nd, 3rd, and 4th, 1999. Evidentiary hearings were again instituted on April 5th, 6th, and 9th, 2000 and resumed on May 9th, and 16th, 2000. A hearing unrelated to custody was held on June 20, 2000. On July 14, 2000 this complainant received a vicious custody order that ran awry and was not remotely congruous with the evidence presented during the custody proceedings. Mr. Carpenter's criminally devised order had

further left this complainants daughter stranded in a perilous situation. Upon this complainants review of the transcribed testimony of February 1st, and 2nd, 1999 and April 6th. and 20th, 2000 discovered that the evidence this petitioner accused Mr. Carpenter of ignoring was in fact deleted, altered, and in many instances of the testimony had been replaced with new dialogue not presented during the above proceedings. These transcripts were then court reporter certified to be accurate and docketed as part of the official record. As a result of the reported discrepancies a court reporter of the above proceedings purportedly had requested Mr. Carpenter's approval to disclose the audio tapes of the proceedings and was denied.

In the course of the adjudicating processes of the above proceedings Mr. Carpenter has violated Pennsylvania statutes 18 Pa C.S.A. 4911. Tampering with public records or information. 18 Pa C.S.A. 4910 Tampering with or fabricating physical evidence. 18 Pa C.S.A. 903. Criminal Conspiracy. 18 Pa C.S.A. 4304 Endangering Welfare of Children.
