Representative Jerry Stern:

Another Thanksgiving day has passed and once again I found myself staring across a somber table at two vacant chairs once filled with life and laughter. My head began shaking uncontrollably in utter disbelief that it has been five years my niece Stephanie Kearns was judicially kidnapped and my departed mother have been with us. All this pain and suffering because both were victimized directly or indirectly by family court corruption. Look up the definition of corruption. Then I drift off and wonder if your children are with you today, or are Judge Carpenter's children with him today. Just to get through this day I somehow find (real or imagined) comfort thinking... excuse me... praying that God will avenge the suffering of my family and others and hopefully Judge Carpenter will celebrate the holidays next year in prison.

Recently we were apprised by an eighteen year old classmate of Stephanie's that she has been acutely depressed for the three years since she has known her. I was told that Stephanie keeps hidden in her bedroom a box she calls her memory box. In this box she keeps letters, cards, photographs or anything else that her dad and family has given her over the years. That is anything that her mother hasn't thrown away. This eighteen year old girl observed that this perpetual depression is because Stephanie misses her father and family. Imagine that! An eighteen year old girl can see what has been causing Stephanie's emotional difficulties. Yet, the corrupt court and mental health professionals chose drugging and medically abusing a helpless child for eight years as the ultimate substitute over reunifying her with her family. This system and anybody that supports it is depraved!

Over the last two years you have been apathetically and passively evasive in responding to letters written to your office by members of my family. A vigilant and informed public (if there was such a thing) might think that each additional term you remain in office, the further disconnected you become from your constituents. Similar to Rick Geist. Quite honestly, I don't know whether to categorize your conduct as ignorant or arrogant.

Regardless, I have a few questions that I think are in your purview and about three years overdue for answers.

What is my governments problem of seeking out and prosecuting judicial corruption? As my brother previously wrote, are you and other officials in Harrisburg waiting until his daughter turns eighteen years of age and becomes another Family Court abuse statistic
