Dear Mr. John Ashcroft:

My family and I are born again Christians. We desperately need your help. We have found ourselves to be trapped in nothing short of a living Hell that has gone on for 4 1/2 years. The information in this envelope is numbered and is to be read in that order.

Exhibit #1 is the criminal complaint that my brother filed with the district attorney's office, the Pennsylvania attorney general's office, and the U.S. Department of Justice. Exhibit #2 are the responses of these offices. How dare the district attorney insult our intelligence by saying that the judge and his court reporters have judicial immunity to commit crimes and remain untouchable for them! We've done our homework and that is not what the PA law books state. Exhibit #3 is Stephanie's drawing that she did for the court-appointed child psychologist, Nancy Baker. It depicts the knife-point abduction from the home. When my brother's attorney asked her, when she was on the witness stand, if she reported this, her response was no, she didn't feel it was any major event in the child's life. I thought kidnapping was a crime! To this day this has not been addressed and the latest school psychologist said Stephanie is suffering from Post-traumatic Stress Syndrome. There has been one trauma after the other in her life and not one of them has been addressed! Exhibit #4 is Stephanie's testimony that the judge totally ignored. Stephanie was 2 months from turning 13 years old. This is a common practice for our county's system. Please read the articles of little Ashley Decker marked Exhibit #5. She cried out, too, and just like Stephanie she was ignored and now she is silent forever. Isn't it ironic that just two weeks before she was killed, she told her grandmother that no one can help her. How God's heart must grieve! Is this going to happen to Stephanie, too? Just another death statistic of the Ignored Holocaust?! The saddest thing about these two children is that both brutal abuses could have been prevented had the system not been corrupt. A friend of mine was working at CYS (Children and Youth Services) at the time of Ashley's case. They told me that they were witness to a conversation and the destroying of physical evidence that CYS said to get rid of because they would be in big trouble with it in their possession. CYS is supposed to be our Child Protective Agency. But who are they really protecting and why? Several months after Ashley's death, McCalpin, the then director of CYS bragged in a newspaper article that the agency was never cited over her death and they never even got as much as a black mark against them!! This county is good at destroying lives. There are many other horror stories that families have shared with us. A grandmother told us her granddaughter at the age of one year was so brutally sexually molested that her vagina was ripped and her rectum was black. What did CYS do about this? NOTHING!! Just like this case-COVER-UP!

Read Exhibit #6 which is Carpenter's malicious ruling. We have not seen Stephanie since July 14, 2000. Exhibit #7 is our local newspaper's article about this ruling. Now look at Stephanie's pictures Exhibit #8. Is this what he meant by meeting her <u>full potential</u>, what 500 pounds!? Is it any wonder that we should be outraged over this corrupted court?! How can this country have a campaign of "Say No to Drugs" when it is the medical field that has nearly 9,000,000 children on them! All under the guise that they are good for you. These children I'm sure like Stephanie would love to have a choice. But the poison being pumped into her body is sanctioned by the sick mother and her cronies. She even gets paid for this child abuse with an SSI check. Crime does pay!! Read Exhibit #9. This is ludicrous that the judge who did the crime has the control over the evidence that would reveal his crime-the audio tapes. We have been told that they are probably missing because they are hot evidence. Exhibit #9. is a testimony from one of my co-workers. LouAnn, my ex-sister-in-law, brought Stephanie into the store where I work. Stephanie is still crying out. Another one of my co-workers who saw Steph that day said she is much bigger than the pictures, her hands shake, and her speech is slurred. This would hardly be from the mega doses of Zyprexa, Prozac, and Depakote! My co-workers are as worried as I am about the drug damage.

Exhibit #10 is a picture of the signs on my parents' property. Please Mr. Ashcroft, be part of the solution and not part of the Ignored Holocaust. Children are dying and so are families. My mother died on July 27, 2000. Thirteen days after Stephanie was ripped away from us. She had asked to see Stephanie before she slipped into a coma which took her into eternity. Stephanie was not permitted to say good-bye or to come to the funeral.

We need an FBI investigation into the corrupt business practices of this court. What are their motives besides money? Who is paying them off? No wonder Pennsylvania holds the record for the second most corrupt state in the nation.

This is not a judgment on the truth or merit of your complaint, it is simply to inform you that this is not the type of case that this office could prosecute. Accordingly, we are unable to assist you.

Inasmuch as you feel that your civil rights were violated, you may wish to contact private counsel, the nearest legal aid program, or the local bar association to determine whether they may be able to assist you.
