**Re: Stephanie Kearns**

Dear Ms. Susan Friedenberger:

Since our meeting of November 5, 2001, I have had the time to reflect on several issues that were raised by my daughter Stephanie and followed up on, by you. You had stated prior to opening our discussion that you were neutral and was not taking sides with either Ms. Frederick or me. However, I wish to take issue with your position in at least twice your presentation or questioning of Stephanie drifted off sides.

First I think it was inappropriate of you to suggest to Stephanie that shared custody was not in her best interest.
