Dear Governor Mark Schweiker:

Over the last few years my sister and I have sent information to the Governor's Office that was in regards to my custody case in Blair County, Pennsylvania. Primarily the information was a plea for help to have investigated the judicial corruption and abuse of power. Since the September 11, attacks on America, I believe my case has become even more significant now that America is heralding our freedom song and democratic way of life throughout the world. Unfortunately blemishing this image is an epidemic of deliberate injustices emanating from our courts of law across Pennsylvania. The result is thousands of Pennsylvania children's lives are being destroyed senselessly each year. In my case a Common Pleas Court judge altered testimony to cover up the gross medical malpractice of my daughter that began with a court appointed psychologist. Five years later my daughter is an emotional and physical wreck. This leads me to believe that our society values a child's life less than the professional careers of so called expert witnesses who testify in court.

In seeking a just resolve to this matter I asked Pennsylvania's Attorney General to investigate the Blair County Court for the abuse of power and unprecedented child abuse. His office shirked its responsibilities claiming that he is not empowered to investigate corrupt state judges. Passing the buck, the Attorney General's Office said it is a matter for the county's district attorney to investigate, if he chooses to do so. The district attorney then side stepped the record tampering matter claiming the judge and his court reporters enjoy judicial immunity. Because the D.A.'s response is an outright lie, I asked the United States Department of Justice to investigate the Blair County Court. Closing the loop the Justice Department refused to investigate the court's crimes and civil rights violations while suggesting that I hire a private attorney to pursue the criminal issues if I believe they occurred. Accordingly, I went to my attorney and requested that he go after the audio tapes of my hearing to prove the judge tampered with the testimony. He refused my request and said he will not file a criminal complaint against the court. I think a prudent person would have to call this a full scale government cover up.

Please find enclosed a Petition for Impeachment against Judge Hiram A. Carpenter that I filed with Pennsylvania's State Legislature on Tuesday, February 19. It appears this is my last chance at finding some justice for my daughter Stephanie and I. If you had read any of my previously sent material you are somewhat familiar with my custody case that began in November 1996. Building on that material I thought that you might be interested in the enclosures. I have recently received letters from the Pennsylvania Bureau Of Professional and Occupational Affairs that dismissed ethics complaints filed against Dr. Nancy D. Baker, Dr. Eugene Polmueller, psychologist Dennis Kashurba and Dr. Richard Bennett. These are all individuals of the psychiatric profession who were involved in some form of

treating my daughter. Amazing enough after a "four year investigation" that was incited by multiple individuals from Blair County accusing Dr. Baker of various degrees of professional misconduct, the Bureau found Baker did not violate any state laws. The Bureau's dismissal of these complaints against Dr. Baker was not done in the interest of justice for the children this woman destroyed through her court appointed counseling and is a blatant endangerment to the public. One only needs to ask any lawyer in Blair County about Baker's professional credibility and they will tell you she is crazy. Any lawyer will tell you that Baker is absolutely not allowed to testify professionally in the Blair County Court. I had also talked with the investigator last June who handled Dr. Baker's case. He told me that he retrieved thousands of documents from the courthouse in which Baker was involved with custody cases. The investigator said he gave the Bureau a case so strong that the licensing bureau would have to file charges against Baker. Again I can't emphasize enough that this woman acting as a child psychologist psychologically destroyed hundreds of children and their entire families.

The investigation of Dr. Polmueller and psychologist Kashurba lasted one and a half years. Same result, the Bureau claimed neither violated state laws. Again, the Bureau identified only one of the numerous ethical issues complained of and cleared Polmueller across the board of all his ethic violations and malpractice. Polmueller admitted on the witness stand that he did no psychological evaluation of my daughter before drugging her and did not care to take any input from me that concerned my daughter's emotional health and well being. These dereliction's are in violation of state regulations for psychiatrists. Again the dismissal of this complaint was violative of public policy and safety. In similar circumstances, Polmueller was run out of the area hospitals for his quackery and for drugging patients needlessly. The Bureau gave no explanation for dismissing the Kashurba complaint.

Finally I filed a complaint against Dr. Bennett of the Altoona Hospital in December 2001 which was docketed for inquiry by the Bureau on January 7, 2002. The letters enclosed are self explanatory. On January 28, an attorney from the Bureau dismissed the complaint without the Bureau doing any investigation. Something smells here since it seems the seed of Blair County corruption has sprouted roots in the state regulatory and law enforcement agencies. I was told back in 1997 by the investigator that the Baker case had become quite complicated and extended since it involved the Blair County Court. Unfortunately for Pennsylvania citizens, I see political pressure forcing a cover up of the court's criminal activity at the expense of a young girl's life. The prima facia evidence I supplied with the complaint against Bennett implicated him of malpractice, psychological abuse of a child and fraud. There was no way the Bureau could have legitimately dismissed this complaint without some form of formal action or a prosecution.

Everyone of the above individuals committed or supported the severe emotional abuse of my daughter Stephanie. All of them knew Judges Carpenter and Kopriva personally and all of their testimony in my custody case was altered to give credence to the psychological butchery of my daughter.
